Guidelines for Installation of

Permanent Automatic Backup Generators

<u>The Village of Blue Heron Pines</u> <u>Permanent Automatic Backup Generator Specifications</u> <u>and Guidelines</u>

- 1. The homeowner will submit a formal application on the enclosed form directly to the ADRC through the management company. Before conditional approval can be extended, the form must be filled out **COMPLETELY**, and properly signed by all affected neighbors.
- 2. The application must accompany a drawing of the property indicating the primary residence as well as the location of adjacent residences. This drawing is to include the location of the proposed generator indicating distances from all adjacent residences. All landscaping that will be incorporated in masking of the proposed generator is to also be indicated on the drawing.
- 3. The Township of Galloway requires a permit to install a permanent backup generator. A copy of the permit must be included in the application to the ADRC. Galloway also requires an inspection of the plumbing (natural gas connection), electrical and total installation. Copies of the inspection results must be forwarded to the ADRC to receive final approval of the proposed installation.
- 3. The generator must be placed on a suitable pad of concrete or masonry pavers.
- 4. The generator fuel <u>must be</u> natural gas. Permanent automatic generators cannot be fueled by gasoline, diesel, or propane. The use of propane would require the installation of propane tanks on the property, a violation of our guidelines already in effect.
- 5. The noise levels emitted by the generator during operation must not exceed 88db. This volume, though high, does not exceed that of a powered lawnmower. It should be understood that backup generators will only be utilized during periods of power outages, and not as an adjunct to the power supply commonly available to the homeowner.
- 6. The area immediately surrounding the generator must be kept free from debris, landscaping, leaves and other items which may impede the operation of the generator, or cause a potential fire hazard.

7. The automatic backup generator must be equipped with an automatic transfer switch. The switch must be rated to the capacity of the generator and the demand. The installation of this requires an inspection by the Township of Galloway **before any final approval and usage of the generator is permitted!** It is strongly advised that the installation of this, and the total installation, be performed by a licensed electrician, and plumber (for the connection of the natural gas line).

On the following pages you will find copies of the applications, communications, acknowledgements, approvals and disapprovals which are possible. You will be responsible for the completion of the Application for the Installation of a Permanent Backup Generator, Installation and Compliance Form, and the Installation and Maintenance Waiver. Upon receipt of all completed forms, the ADRC will meet and discuss the proposals and determine the outcome. Following that, (usually a period of less than 5 business days), you will receive a Conditional Approval, conditional with regard to the satisfactory completion as you defined and submission of all required inspections by Galloway Township. When all work is completed, you will receive a Final Approval, signed by the Chairman of the ADRC, copies to the management company. If, for some reason, the application is denied, you will receive a disapproval notice and requirements necessary to proceed. outlining the reasons Remember, you must have a Conditional Approval before proceeding with the installation! It is understood that in certain circumstances the installation of the backup generator must immediately installed to preserve the health of the homeowners. In these instances, the chairman of the ADRC has the power to grant immediate conditional approval. However, it is still the responsibility of the homeowner to complete all requirements herein described to comply with this guideline.
